

## 2024 VAAL Exhibit at LaGrange Art Museum

August 24 – October 5, 2024

- Works may not exceed 36” in width and must be ready to hang. (If you have something larger, please contact Jennifer.) All hanging works must be wired, no sawtooth hangers. Any unframed canvases to be gallery-wrapped with no visible staples.
- Members of VAAL may enter up to 2 works. Final determination is reserved by exhibition curator as to whether one or two pieces will be shown.
- 20% of sales go to LAM. These proceeds help support the education opportunities at the museum. All submissions per artist must be offered for sale.
- \$40 exhibit fee (\$55 for two works) and the second page of this form must be sent to the address below, or paid online and emailed to [jydemery@gmail.com](mailto:jydemery@gmail.com) by July 31. **Do not drop the forms or money at the museum.**

Membership dues *must* be paid prior to exhibit registration. If you have not paid your 2024 dues, please include that amount in your payment. Payments can be made online or mailed to the address below:

# VAAL ART SHOW GUIDELINES

Opening August 24, 2024, 6-8

1. The artist must be a currently paid-up VAAL member and has paid all entry fees required.
2. Members may submit 2 separate pieces of artwork to the museum at a pre-organized delivery time for consideration. The Museum curator will try to hang at least one of your pieces of art as space allows. The second piece may be hung if space allows.
3. Since this show is supposed to pique interest in many generations, no artwork will be displayed that could be considered offensive or objectionable; examples might include full nudity, controversial subject matter, satanic messages, bloodied gore, or political items.
4. All artworks must be no wider than 36 inches because of space limitations.
5. All work must be original in concept and execution. All artworks must have been created solely by the submitting artist without the help of a teacher or another artist in a class or workshop. Work must have been completed in the last 3 years from the date of delivery.
6. The Artist must own the rights to any reference materials used for the project, i.e. reference photographs.
7. No digitally manipulated work, painted giclee prints or any other types of reproductions, and no manipulated or painted over photos will be allowed. No diptychs, triptychs, or multiple panels will be accepted.
8. Entries may not have been exhibited in any prior VAAL show.
9. Work must be suitably framed, wired, and ready to be hung by the Curator. Saw tooth hangers cannot be accepted.
10. All entries will be made at the risk of the entrant. Care and caution will be exercised in the handling of all artworks; however, the Museum cannot be held responsible for any damage.
11. All works must be for sale and must be priced according to your standard pricing schedule.
12. The Judge for the 2024 VAAL show will be Margaret Dyer from Atlanta. Please check “MargaretDyer.com” for full resume, galleries, awards, and videos.
